Sec 143 BNS (Sec 370,IPC)

- Whoever, for the purpose of exploitation, (a) recruits, (b) transports, (c) harbours, (d) transfers, or (e) receives, a person or persons, by—
 - using threats, or
 - using force, or any other form of coercion, or
 - by abduction, or
 - by practising fraud, or deception, or
 - by abuse of power, or

- by inducement, including the giving or receiving of payments or benefits, in order to achieve the consent of any person having control over the person recruited, transported, harboured, transferred or received,
commits the offence of trafficking.

.

- **Explanations**

1. The expression “exploitation” shall include any act of physical exploitation or any form of sexual exploitation, slavery or practices similar to slavery, servitude, or the forced removal of organs.
2. The consent of the victim is immaterial in determination of the offence of trafficking

UNIQUENESS OF ITPA, 1986

- **RECOGNISES**

- COMMERCIAL SEXUAL EXPLOITATION IS REVENUE GENERATING AND ANY INTERVENTION WITH VICTIMS HAS TO BE DONE WITH CARE

- FEMALE VICTIMS COULD NORMALISE THIS EXPERIENCE AND BECOME PART OF THE CRIME SO CORRECTIONAL INSTITUTIONS AND NOT IMPRISONMENT FOR THOSE IN CRIME (2-5YRS)

- HARMFUL ELEMENTS MAY APPLY FOR CUSTODY OF VICTIMS AND HENCE HAS TO BE VERIFIED

- VICTIMS WILL REQUIRE QUALITY PERIOD TO RECOVER AND REHABILITATE (1-3YRS)

- INVOLVEMENT OF CIVIL SOCIETY ORGANIZATIONS IN IMPLEMENTATION OF THE ACT

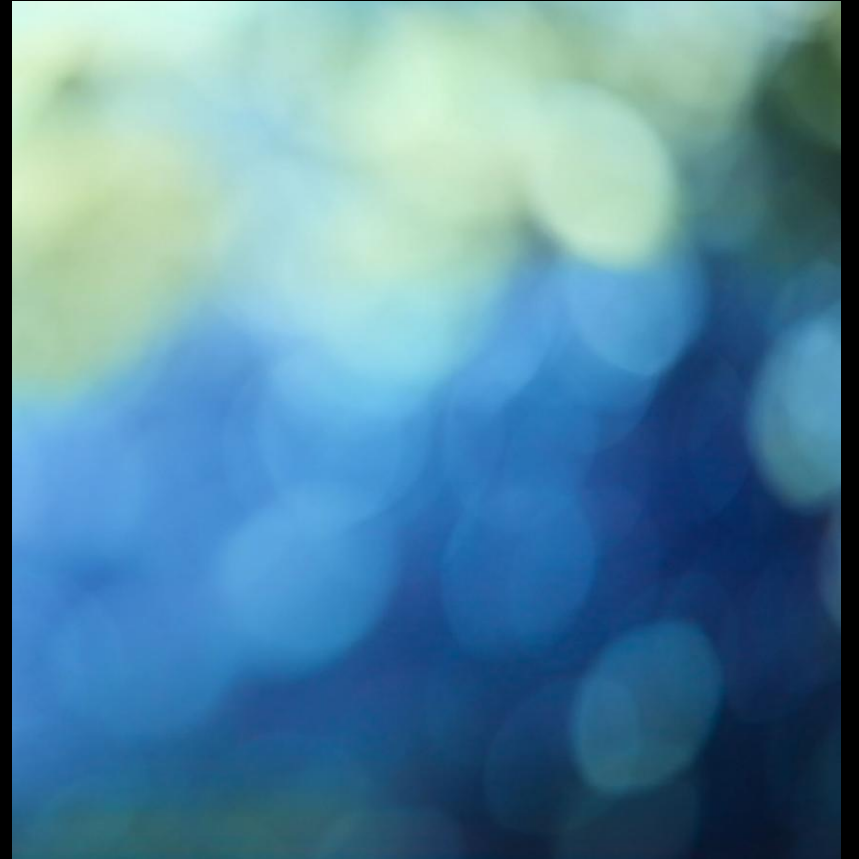

CHALLENGES

CRIMINAL JUSTICE SYSTEM, WELFARE DEPARTMENTS AND CIVIL SOCIETY ORGANISATIONS

CRIMINAL JUSTICE SYSTEM

- CHILD/ADULT BIAS
- AHTU- NOT A POLICE STATION-ORGANIZED CRIME DOES NOT GET INVESTIGATED
- ITPA NOT FULLY IMPLEMENTED
- INADEQUATE RESCUE/RESTORATION PROTOCOLS
- REHABILITATION NOT UNDERSTOOD
- DLSA ROLE NOT UNIFORMLY RESPONSIVE
- INADEQUATE VICTIM WITNESS PROTECTION-ADULTS

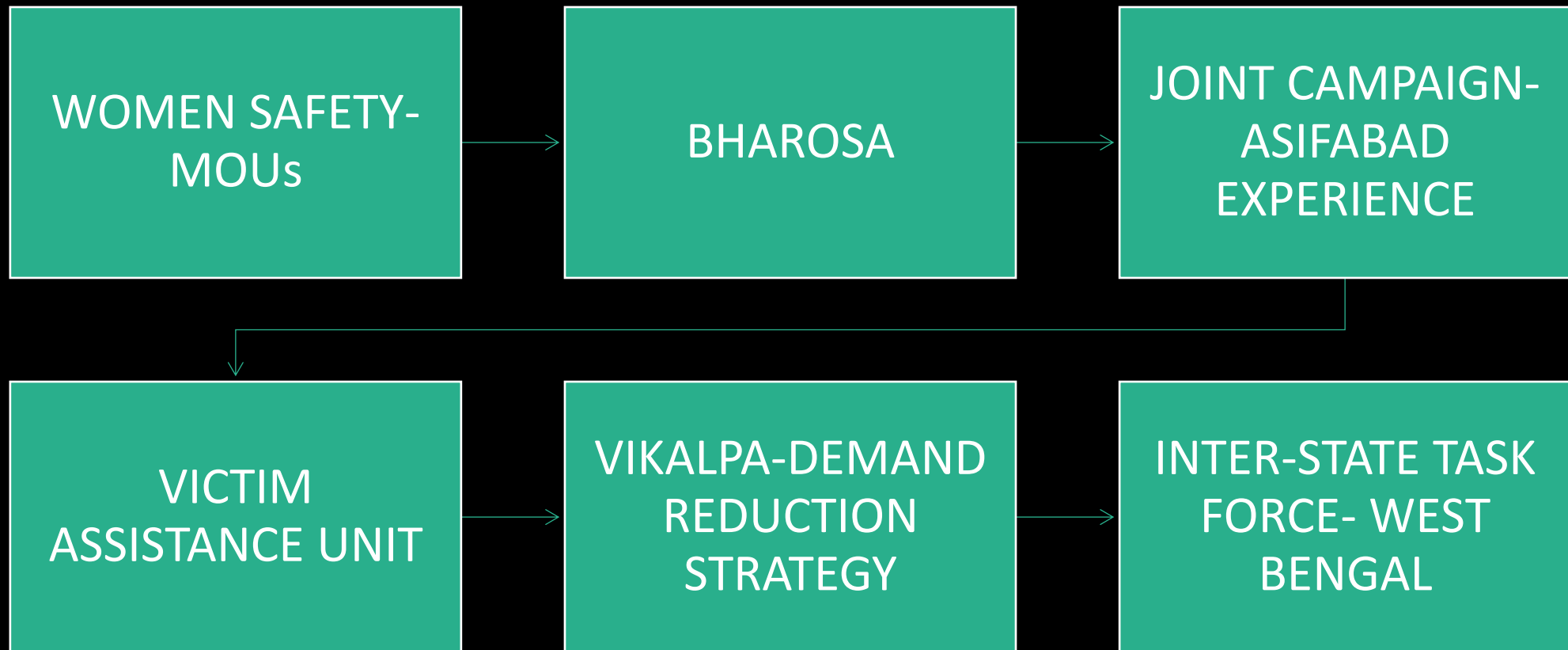
WELFARE DEPARTMENTS

- POLICY IMPLEMENTATION NOT A PRIORITY
- INADEQUATE /POORLY FUNDED PROTECTIVE HOMES
- INTERNATIONAL REINTEGRATION-FUNDING, PROTOCOLS
- REACTIVE AND NOT PROACTIVE
- DPOs INADEQUETLY PREPARED/MONITORED

CIVIL SOCIETY ORGANIZATIONS

- FEWER ORGANISATIONS
- PROJECT ORIENTED VS CAUSE ORIENTED
- DEPENDENT ON GOVERNMENT FUNDING
- UNWILLING TO TAKE UP ADVOCACY FOR VICTIMS
- STAFFING-STRESS/BURN OUT

FIGHT AN ORGANIZED CRIME BY UNITING AS ONE SINGLE FORCE

- IMPLEMENT THE EXISTING LAWS ROBUSTLY
- UNDERSTAND THE TRAUMA INFORMED APPROACH IN CRIME INTERVENTION ESPECIALLY RELATED TO SEX TRAFFICKING.
- PRIORITISE THE MOST VULNERABLE AS A MATTER OF PRACTICE
- INVEST AND NURTURE PROACTIVE PARTNERSHIP
- STRATEGIC INTERVENTIONS IS MORE SUSTAINABLE THAN REACTIVE INTERVENTIONS.
