Subject : Prohibition of flying of unmanned aerial objects, including drones, balloons, unmanned aerial vehicles, unmanned aircraft systems, etc., on the occasion of Independence Day 2016 for Security and Maintaining Law and Order in the limits of Bengaluru City.

**PREAMBLE**

WHEREAS, In view of the Independence Day 2016 celebration and for maintaining law and order under the prevailing security scenario and to avoid untoward incidents, I consider that it is absolutely necessary to ban the flying of unmanned aerial objects, including drones, balloons, unmanned aerial vehicles, unmanned aircraft systems, etc., within the limits of Bengaluru City Police Commissionerate.

**ORDER: No. SB / PO-13 / 2016, DATED: 12-08-2016**

NOW, THEREFORE, in exercise of the powers conferred under section 144 of the Code of Criminal Procedure, 1973, I, N.S.Megharikh, Commissioner of Police and District Magistrate, Bengaluru City, hereby prohibit the flying of all unmanned aerial objects, including drones, balloons, unmanned aerial vehicles, unmanned aircraft systems, etc., within the limits of the Bengaluru City Police Commissionerate on 13-08-2016, 14-08-2016 and 15-08-2016.

**ORDER NO. No. SB/ZP & TP ELN-5(3)/2016 DATED: 09-02-2016**

NOW, THEREFORE, in exercise of the powers vested in me under sub-section (1) and (3) of Section 144 of the Criminal Procedure Code, I, N.S.MEGHARIKH, IPS, Commissioner of Police and District Magistrate, Bengaluru City do hereby prohibit sale, consumption, procurement and storage of liquor wine, arrack or any other intoxicant in any wholesale and retail outlets, order that all liquor shops, wine shops and bars situated in the polling areas under the jurisdiction of the following Police Stations of Bengaluru City will remain closed from dated:**12-02-2016, 07-00 AM to 12-00**

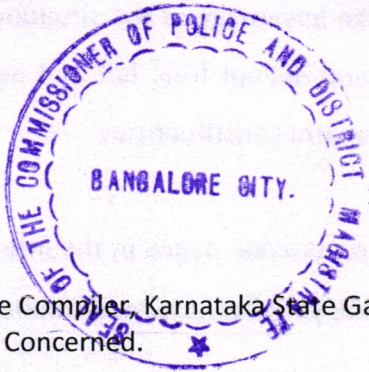
