# Newer forms of trafficking

- Shift from traditional brothel based prostitution to online
- Use of social media like Facebook, twitter, Instagram, What's app for trafficking and online soliciting
- Commercial classified website like *Locanto* having servers in other countries used by traffickers specially Escort services operations
- Use of *dark net*
- Intercountry Trafficking & smuggling for cyber crimes-Myanmar Case study
- Intercountry trafficking for organ removal- Turkey, Srilanka
- Human smuggling to Nicaragua flight with 303 passengers detained in France on suspicion of trafficking

# Trafficking for committing Cyber Crime

- In September 2022, 300 IT employees from Telangana, Tamilnadu and other Indian states were recruited for SEZ Mayawady region of Thailand.
- They were smuggled to call centers in Myanmar and forced to indulge in committing online financial frauds.
- Third degree torture methods like water jail, use of electrical shocks were used to force them for committing crimes.
- Victims paid ransom to traffickers for rescue.
- Inter country rescue operation by MEA with help of Thailand / Myanmar Government.

#### Lured to Thailand, 300 Indians now forced into cybercrime in Myanmar

CHENNAI: More than 300 Indians, including at least 60 from Tamil Nadu, have been held hostage by a gang at Myawaddy in Myanmar where they are for open in App bercrime activities, multiple sources told TOI. People from some other countries were also being held by the racket.

#### BRUTAL TREATMENT

The Indians were initially promised IT jobs in Thailand, but later taken to Myanmar and held hostage

Being forced to do illegal work for 15+ hours/day; beaten up & given electric shocks if they refuse

Indian embassy working with Myanmar government to rescue the captives Red light Areas in India without license/ permission

#### <u>Closure of brothels & eviction of offenders</u>

Sec.18. (1) of Immoral Traffic Prevention act -Closure of brothel and eviction of offenders from the premises. Whenever there is conviction under Sec 3 and & 7 ITPA

(2) Judicial Magistrate on conviction under Sec.3 & 7 ITPA can close the brothels and eviction of offender on own or on representation from prosecutor

(3)No appeal in any Civil & Criminal Court Sec. 18 (3) ITPA, 1986

#### Prevention –Reduce the demand

More the demand more will supply.

Buying and selling of Girls from one trafficker to other like commodity- Naya Maal aaya hai-Mehaboob ki Mehandi of Hyderabad demolished in 1990s. *" Jab tak Mard Jinda hai tab tak hamara dhanda chalta rahega"* 

Can we reduce the demand?-Customer or Clientele is punishable U/s 5(1) (d) & sec. 7(1) of ITPA ( Cherian vs. Kerala , 1973 Crl. L.J. 839). Sc. 114 IPC as customer is Abettor to Crime. If Victim is child then sec. 376 IPC and POCSO sections attracts to customer

- O Supply of trafficked individuals can be reduced by providing vulnerable populations with better economic opportunity and rule of law.
- OSweden Model- Educate all stake holders, legal amendment, heavy punishment for clientele / customers.
- OLaws like TVPA of USA

#### **CONSTRAINTS**

- **O**Difficulties in reintegration of sex workers and their children into mainstream
- OAlternative source of livelihood to victims not matching to their lifestyle
- OAttitudinal changes in police force is a need of time.
- OLack of coordination amongst Government agencies

# Yadagirigutta Operation 2018

- 30<sup>th</sup> July 2018 She Teams, Child line staff, Yadgirigutta Police raid on Yadgirigutta Brothels
- Rescued 34 Minor Girls & 3 Major Girls, arrested 42 organizers (32 Female, 10 male). 23 cases of Yadgirigutta PS, 1 case of Abdullapurmet.
- FIR U/S 366 A, 370(1) (5), 376 r/w 114, 372, 373 IPC, Section 17 of POCSO act, Section 3,4,5,6,7,9 ITPA
- In 22 cases DNA conducted.
- 20 Brothel houses sealed for 3 years under 18 (1) ITPA by orders of RDO
- Rescued victims rehabilitation in Prajwala Home at Amangal & Shishu Vihar, Nalgonda
- One victim's identity traced through Adhar card. Repatriated through Court to her parents in Eluru District, A.P.
- High Court PIL. Stay on trial from high court on 22 cases under POCSO and trafficking sections

### Case study 1 University Professor convicted for forcing minor into Sex trade

On 2/8/2005 Tirupati police in Chittur district of AP state, India busted a wellnetworked trafficking network with the arrest of a woman Professor

 Police swooped down on the two couples in the pent-house & rescued two minor victims.

# Tirupati case study contd.

- Police also seized incriminating evidence like cell phones, liquor bottles, porn literature and condoms
- <u>Conviction</u>:-The Assistant Sessions Judge, Tirupati, sentenced the accused for seven years imprisonment and also levied a penalty of Rs.22,000 (\$350)

### Case study 2 10 years conviction for inducing Indian girl for sex trafficking to Singapore

- Trafficking from A.P. state, India to Gaylang, Red light area of Singapore
- On the promise of Nursing school admission victim was lured. Accused was earlier brothel keeper at Singapore.
- 2 traffickers got convicted for 10 years imprisonment under Section 5 of ITPA.
- Training of I.O. , victim & witness protection and trial monitoring has ensured conviction

#### Case study 3 Nepal network-Trial through Video conference case, ended in conviction

- 2009 case of Nagpada P.S. of Mumbai, Maharashtra. Victim rescued from a brothel in Kamathipura and repatriated to Nepal by Rescue Foundation NGO
- $\odot$  Victims presence in trial was issue
- Through Skype video conferencing trial was done at Special Court.
- Case ended in conviction for 3 years.

### Case Study 4 South India to Dubai network of human smuggling turning into human trafficking

- Trafficking of young women from Andhra Pradesh, Karnataka, Kerala & Tamilnadu states to Dubai in the guise of domestic help and sold to brothels
- Year 2010 3 rescued victims of flesh trade in Dubai repatriated to their native place Mandapeta of East Godavari District. Case registered.
- $\circ$  7 accused from India were arrested.

## Contd.

- Impounding Passport:-Joint Secretary, external affairs ministry at Hyderabad addressed a letter to Indian Consulate at Dubai about wanted accused.
- King pin of racket trafficker native of Karnataka, India deported back from Dubai (RCN, extradition are time consuming) and arrested on arrival at Mumbai.

#### Case Study 6

On line sex racket run by traffickers of Tanzania busted in Hyderabad, India

- Perpetrators uploaded photos on the website <u>locanto.com</u> (web site server in foreign country)and were soliciting online. (New US Law against on line sex advertisement)
- Cops registered a case against the trio under section 370 (a) (trafficking) of the IPC, sections 3, 4 & 5 of Immoral Traffic (Prevention) Act and section 14 of the Foreigners Act.

# Online sex racket busted, T'wood artiste rescued

Hyderabad: Special Operation Team (SOT) sleuths of Rachakonda on Wednesday busted an online sex racket and arrested the organiser. Police have also rescued the victim, a Tollywood junior artiste. The accused has been identified as Reddy Naresh Naidu alias Mahesh, 25, a resident of Yousufguda.



According to the police, Mahesh had uploaded the victim's images in Locanto and other websites to attract customers. After police conducted a decoy operation, Mahesh was arrested. Another accused managed to escape.

"The victim used to work in daily soaps, but was not getting roles for the past one year. After she started facing financial problems, she got intoflesh trade," said inspector Naveen Kumar.

Police said that the accused were charging Rs 20,000 from each customer for the service. Through Locanto, the customers would contact the accused and then, they would ask them to come to their apartment in Uppal.

The accused would also get customers from other states, police said. According to the police, cops posed as customers to contact the accused and went to the apartment at Uppal in a decoy operation.

"Only after police found enough evidence and became sure of the flesh trade, the accused was nabbed," the inspector added.

Following the arrest, police have booked the accused under Section 370 of the IPC and sections 3, 4 and 5 of The Immoral Traffic (Prevention) Act. The victim was sent to a rehabilitation home and a manhunt has been launched to arrest the second accused.

#### Case Study 7 Delhi operation

- In 2007 operation to rescue victims from GB Road brothels in New Delhi
- Operation successful but patient died
- Interstate rescue operations problems of coordination with other stake holders. Rescue home/ Medical treatment for HIV affected issues

# Case Study 8 Operation Wani, Yeotmal & Chandrapur

- 2007 Victim from Khammam was sent to Hyderabad for domestic work
- Sold to brothel in Wani, Yeotmal of Maharashtra to Pune red light area
- Rescued by Rescue foundation Mumbai
- On her information raids at Wani , Yeotmal where rescued 37 victims of A.P., Telangana, Orissa state

# Worksite school model

 BEST PRACTICE:- Worksite school model of commissioner of police Rachakonda Mahesh Bhagwat for migrant Odisha state children rescued from Brick kilns at Hyderabad. IAS, IPS partnered with civil societies, brick kiln owners association, Education, Labour dept. has ensured continuous education of children in their mother tongue Oriya & extended Government schemes like Midday meal scheme for them. 2018 IACP, USA award of leadership in civil & human rights individual category received by CP Rachakonda for this

### FORCED LABOR ..

- Operation Smile
  - 370 children from Orissa working in hazardous condition in Brick Kilns rescued and traffickers arrested
- As a part of rehabilitation:
  - Oriya language schools started for rescued children in PPP(Public Private Partnership) mode.
  - Mid day meal scheme launched by District Collectors. Rs 1 (\$0.015) per KG Rice scheme to parents in partnership with NGO.

# Schools for kids of brick kiln workers

#### CITY BUREAU Hyderabad

Several hundreds of miles away from their homes, nearly 400 children from Odisha whose parents work in brick kilns here, can now get enrolled at schools where they will be tutored in Oriya language. The Rachakonda police, along with the local district administration, are opening two schools for the children. Close to 370 children were rescued by the police along with the district administration last month.

"All the children had come along with their parents to work in brick kilns. We have counseled the parents and asked them to enroll their children at the school where they will be taught in Oriya language," said Mahesh M Bhagwat,

Commissioner of Rachakonda. One school was opened on Saturday at Chikatimamidi village in Bommalaramaram mandal of Bhuvangir district. Around 170 children are enrolled at the school. One

more school will be opened at Chotuppal or another 200 children were rescued from brick kilns.

The district administration is providing accommodation, food and other articles like slates, chalks and books. Two teachers familiar with Oriya language are now teaching them. "We wanted the children to study in Oriya so that they continue their education when they go back to their native places after six months or so. Again when they are here, they will continue their education," Bhagwat told Telangana Today.

Another eight teachers will join the schools in the next few days. "I had personally contacted a local NGO in Odisha and they arranged the teachers. The teachers will be paid salaries by the district administration," he said.

The owners of brick kilns, too have come forward to support the education of the children. They are contributing whatever possible in the form of books and clothes to the children.
