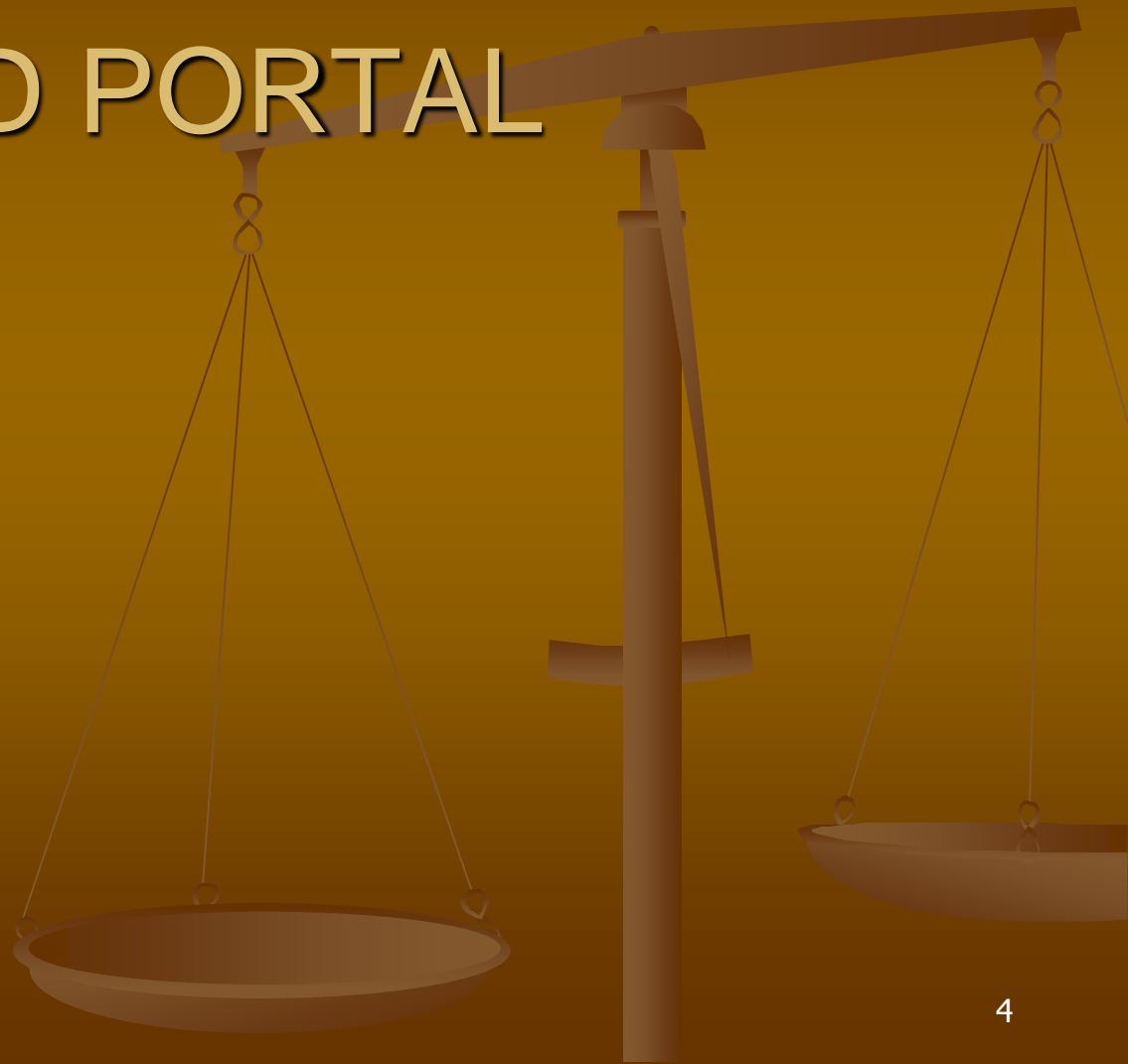

Waybills/Statutory Forms

- Use of **Waybill** for all the consignments under VAT & CST Acts has become mandatory for all the ***dealers along with the goods vehicle***(i.e VAT & CST)
- **Form C** is issued by the dealer for ***purchasing goods*** from a dealer outside the state.
- **F form** is required to be produced as proof of stock transfer. As per section 6A(1) ***submission of F form is mandatory to prove stock transfer***. Otherwise, the transaction will be treated as sale for all purposes of CST Act.
- **H Form** ,A sale or purchase of goods shall be deemed to take place in the course of the export of the **goods out of the territory of India**

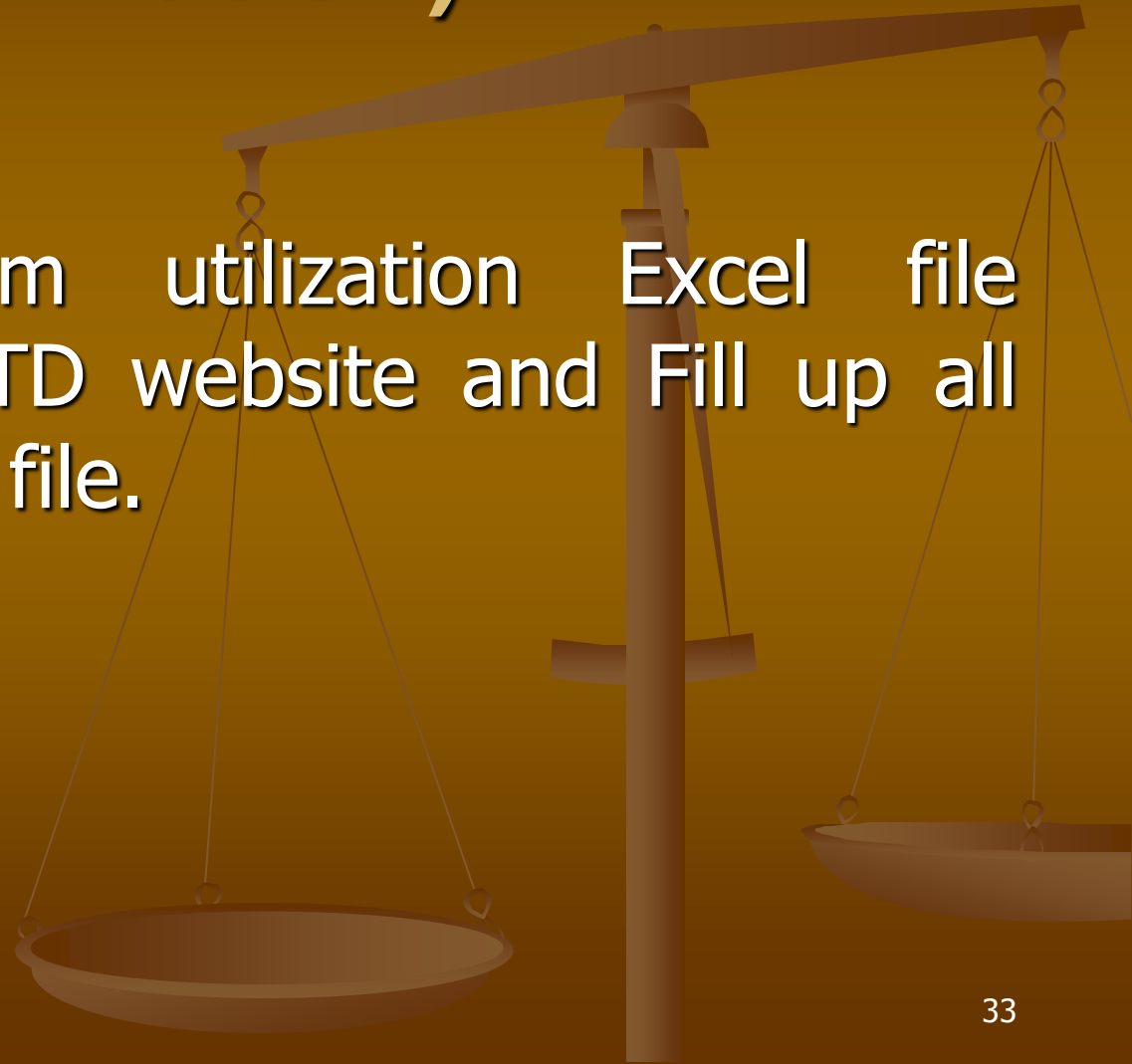

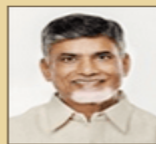

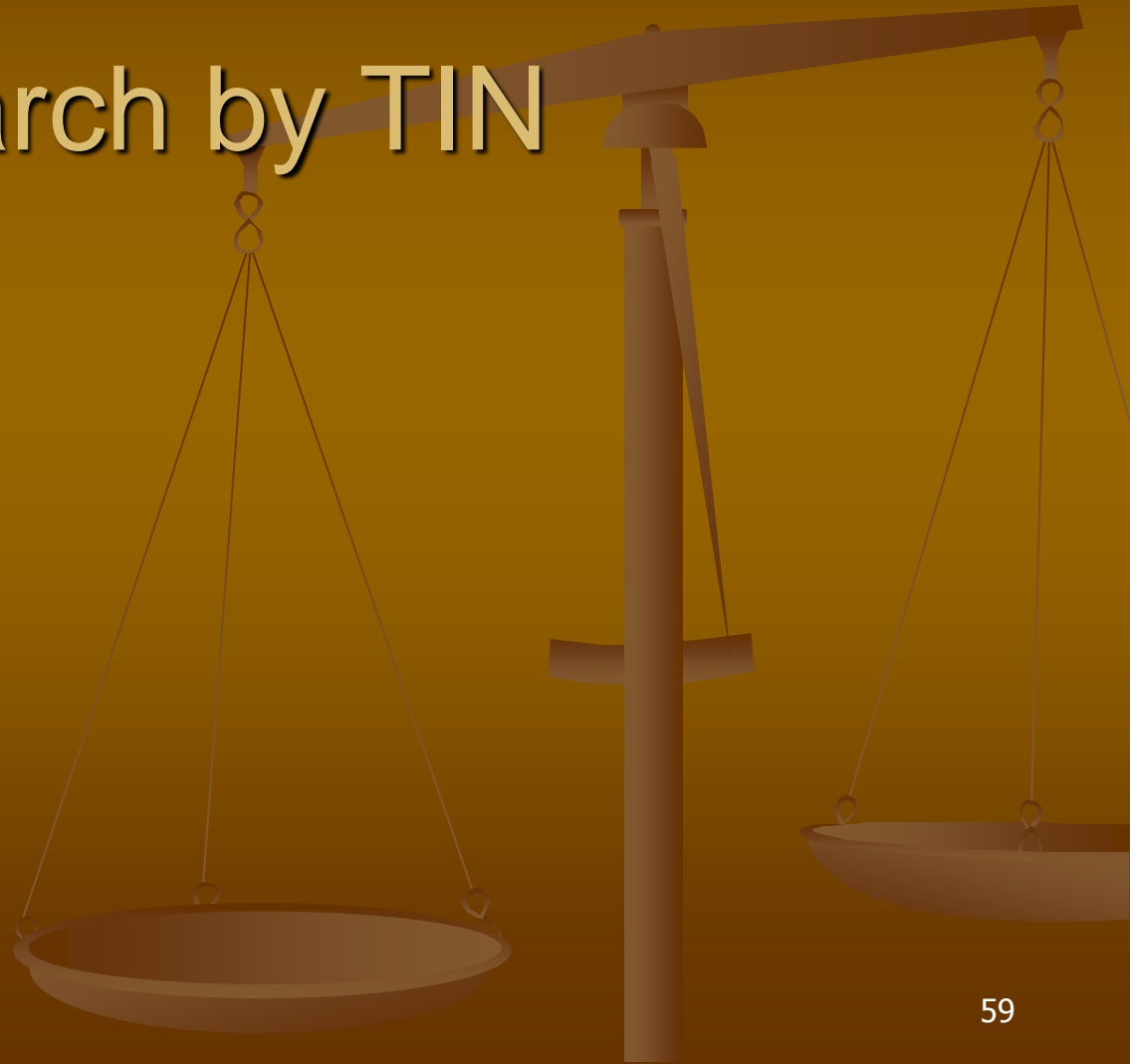
