# MISSION KAKATIYA

*The mission aims at retrieving the lost glory of minor irrigation in the state with community participation for ensuring sustainable water security.*


## SAILENT FEATURES

- Embarked in 2014 – in the new state of Telangana
- Revival and restoration of 46531 Minor Irrigation tanks in a phased manner over a span of 5 years.

## CHALLENGES FACED

- 255 TMC water was allocated for minor irrigation sector to irrigate 25 lakh acres but the actual area being irrigated was 9 to 10 lakh acres.
- Gap in ayacut for 15 lakh acres has been observed due to:
  - Loss of water storage capacity due to siltation
  - Dilapidated sluices, weirs and weak bunds
  - Defunct feeder channels
  - Dilapidated condition of Irrigation canals

# OBJECTIVES

- 
- De-silting the tank beds to restore original water storage capacity of tanks
  - Repairing dilapidated sluices, weirs etc.
  - Strengthening the tank bunds to its original standards
  - Repairing the feeder channels
  - Works to supplement/filling Minor Irrigation tanks through canal networks
  - Re-sectioning of irrigation channels

# ADVANTAGES

• Increase in water retention capacity and thereby decreasing the number of wettings

• De-silting improve ground water recharging capacity and increase the capacity of the tank

• Reduction of fluoride content in the ground water

• Silt can be used as nutrient / fertilizer to the plant which generally reduces the usage of fertilizer

• The yield of the crops like cotton and chillies is increased by 20 to 30%

## ➤ Quality Issues/Chronic drought conditions-scarcity of drinking water

- Every alternative year, the state was facing drought situation.
- Deficit rainfall in 6 years during last decade.
- Due to over exploitation, the ground water table depleted and quality effected
- Depletion of Ground water – by more than 2 metres in last 10 years
- 82% Drinking water Schemes dependent on Ground Water sources
- Water quality issues-excess fluoride(1043 habs),nitrates(163 habs),TDS(187 habs)
- Transportation to about 15% habitations in Summer

# INSPIRATION FOR MISSION BHAGIRATHA

Siddipet Comprehensive Drinking water scheme conceived and implemented in the year 1996 by the then MLA of Siddipet and present Hon'ble Chief Minister Shri K. Chandrasekhar Rao garu.

## MISSION

- To provide 100 lpc of treated drinking water through functional household tap connection in rural habitations of Telangana.
- To provide bulk water supply to all Urban Local Bodies, to enable them to supply @135 lpc in Municipalities and @150 lpcd in Municipal Corporations.
- To meet the needs of the Industry and provide them with raw/treated water as required (10% of the overall demand is committed for this purpose).



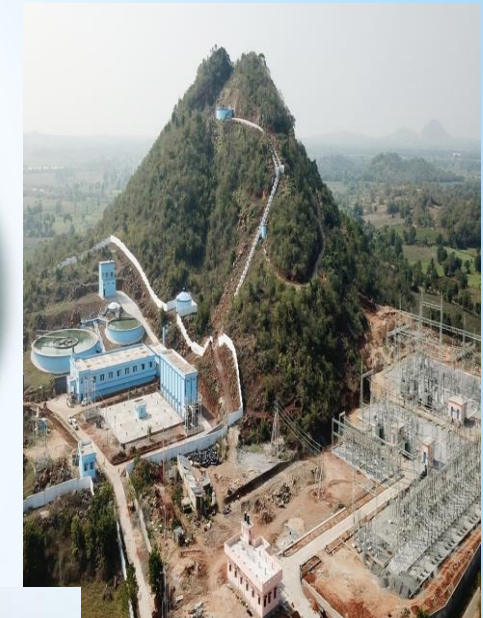


# STAGES TO REACH HOUSEHOLD

## Typical methodology

### Main stages involved are:

- Sourcing water, through Intake Wells, from major rivers or reservoirs fed by these rivers
- Purifying the raw water in nearby Water Treatment Plant (WTP)
- Pump treated water to Over Head Balancing Reservoirs (OHBRs) at the highest points
- Transmit from highest point through secondary pipeline network to all the OHSRs located in habitations by gravity
- Distribute to each household through a modern, rationalized intra village network by providing tap connection to each household

## 'Mission Bhagiratha a model for all States'

HUDCO CMD lavishes praise watching potable water flow from taps

It was a walk down the memory lane for M. Ravi Kanth, Chairman and Managing Director of Housing and Urban Development Corporation Limited (HUDCO), when saw water flowing from the taps in Pothireddypally Gudem habitation near here on Saturday.

"I never drank safe drinking water all my childhood. The tank in our habitation in Palakollu, infested with algae and water hyacinth, was the year-long source of water. I've grown immune to all that," he recalled.

On Saturday, Mr. Ravi Kanth along with a team of officials, including HUDCO State and regional heads, turned on the taps tasting water here, after visiting its source - off take point at Akkampally Balancing Reservoir and filtration project at Kodandapur.

The Kodandapur segment of the Mission Bhagiratha the State's programme to provide safe and tapped

drinking water to every household - supplies to 352 habitations in the area.

**Major role**  
HUDCO, 'Mini Ratna' public sector undertaking that promotes sustainable habitat development, was one of the

first ones to sanction a loan for Mission Bhagiratha. The 'greenfield project' was released ₹ 4,750 crore in two phases, say officials. And all the intake wells from the source point were built from those funds.

"I always felt happy for

my role as a Telugu man in sanctioning that loan. But witnessing development, in a fluoride-affected place like Nalgonda, which I didn't experience as a child is very different," Mr. Ravi Kanth said, interacting with residents of Pothireddypally Gudem.

**Role model**  
He was all praise for the mega project Mission Bhagiratha and said the State government by fulfilling the basic need of safe drinking water soon will be a model for other states.

Interacting with the media, Mr. Ravi Kanth, a 1986-batch Kerala cadre IAS officer, recalled his association with *The Hindu*. "It used to cost 35 paise when I started reading *The Hindu* in 1979. Then, the paper was delivered at Andhra University in the afternoon, with the arrival of a train from Hyderabad. I think I owe my success to your newspaper," he signed off and turned to interact with more residents in the village.

**PEDDAREDDYPET (MEDAK DISTRICT):** Maharashtra Water Supply and Sanitation Minister Babanrao Lonikar said that Mission Bhagiratha will be replicated in Marathwada region to address the water problem.

He said that this scheme would be discussed in their cabinet shortly and requested the officials to present details of the scheme so that it would be easy for him to explain his colleagues.

Along with a team of officials, Mr. Babanrao visited ongoing Mission Bhagiratha works at Peddareddypet near Singoor Project. Spending about an hour, the Minister enquired as to how the programme was planned and being implemented.

During his visit to the Singoor Dam he also asked as to how the existing drinking water schemes were integrated with the Mission Bhagiratha. Later speaking to reporters Mr. Babanrao said that it was amazing to see that the newly formed Telan-

gana was able to make a progress on planning and implementation of schemes like Mission Bhagiratha within a short period of one year.

"We are having drought for the past three years and drinking water has become scarce commodity. We have to supply water to areas like Marathwada and to Lathur in tankers and sometimes even

in trains. Groundwater level in eight districts of Marathwada region fell to as low as 1,000 feet. We have used 4,000 tankers to supply drinking water and about Rs. 600 crore was spent for this purpose," said Mr. Babanrao.

The Minister said that Chief Minister Devendra Fadnavis had sent them here to study Mission Bhagiratha

Scheme and they were also studying the Gujarat model where drinking water supply was good. He informed that both the models would be studied to supply drinking water to the people of Maharashtra.

Mission Bhagiratha Engineering in Chief Surender Reddy and others were present.

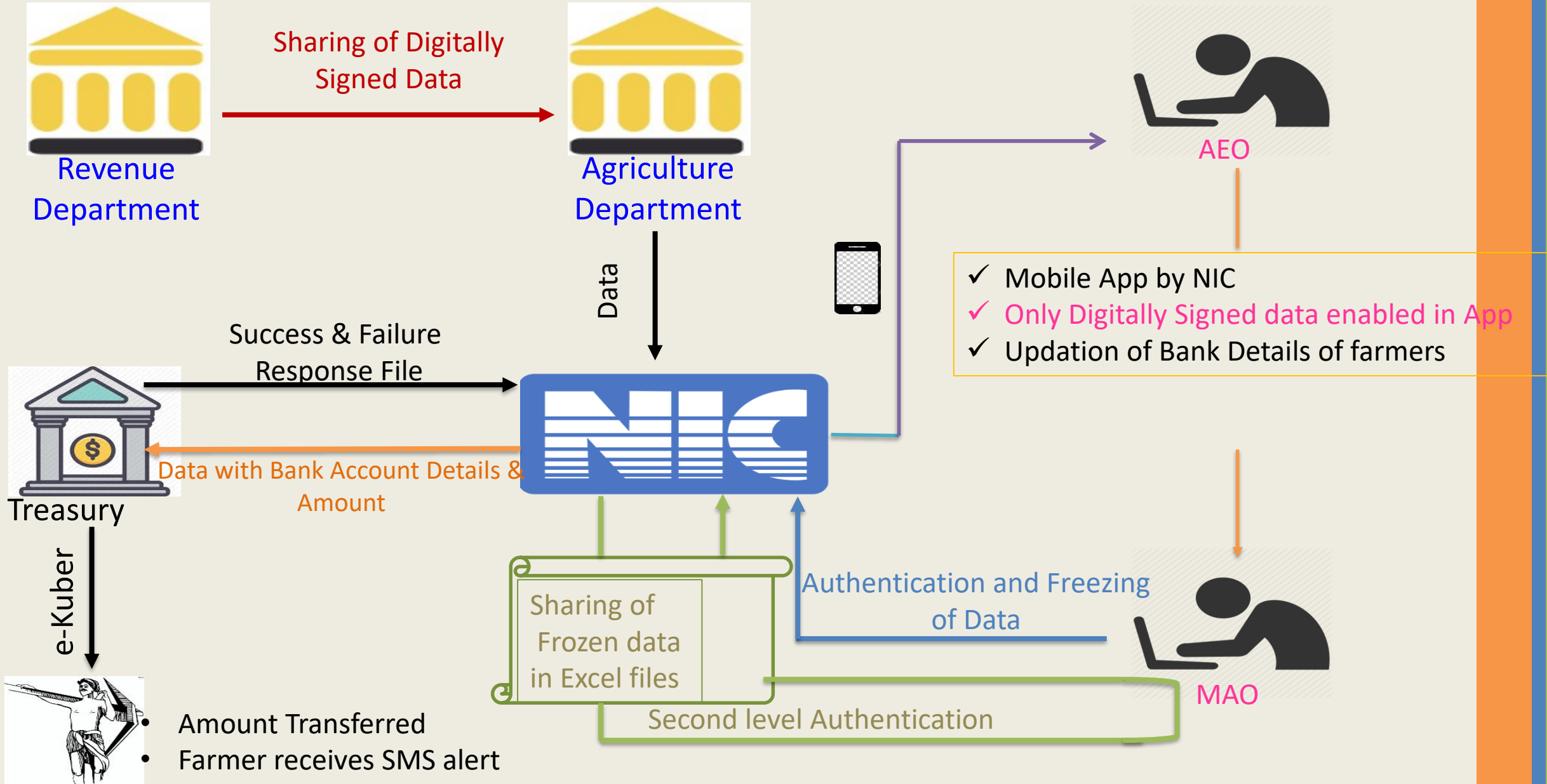

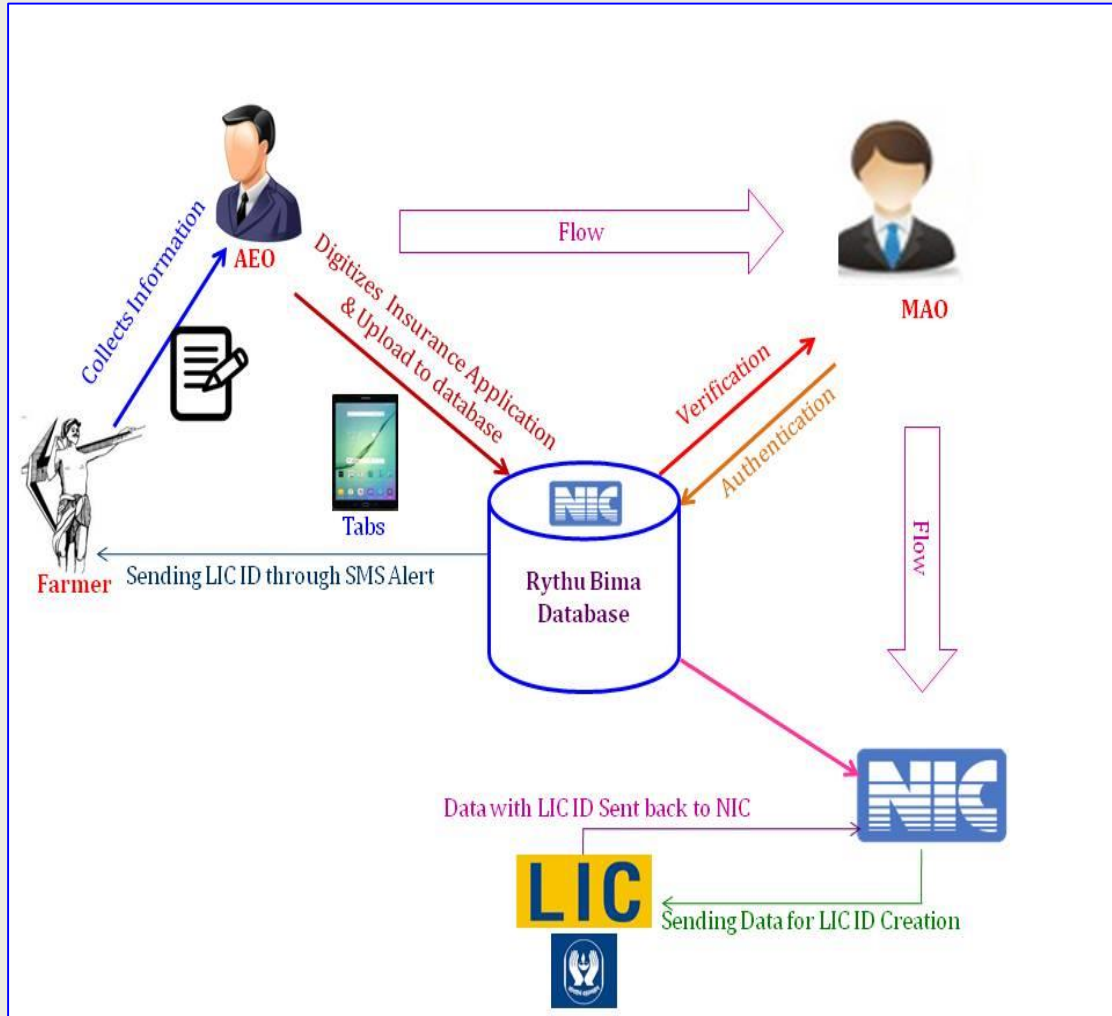

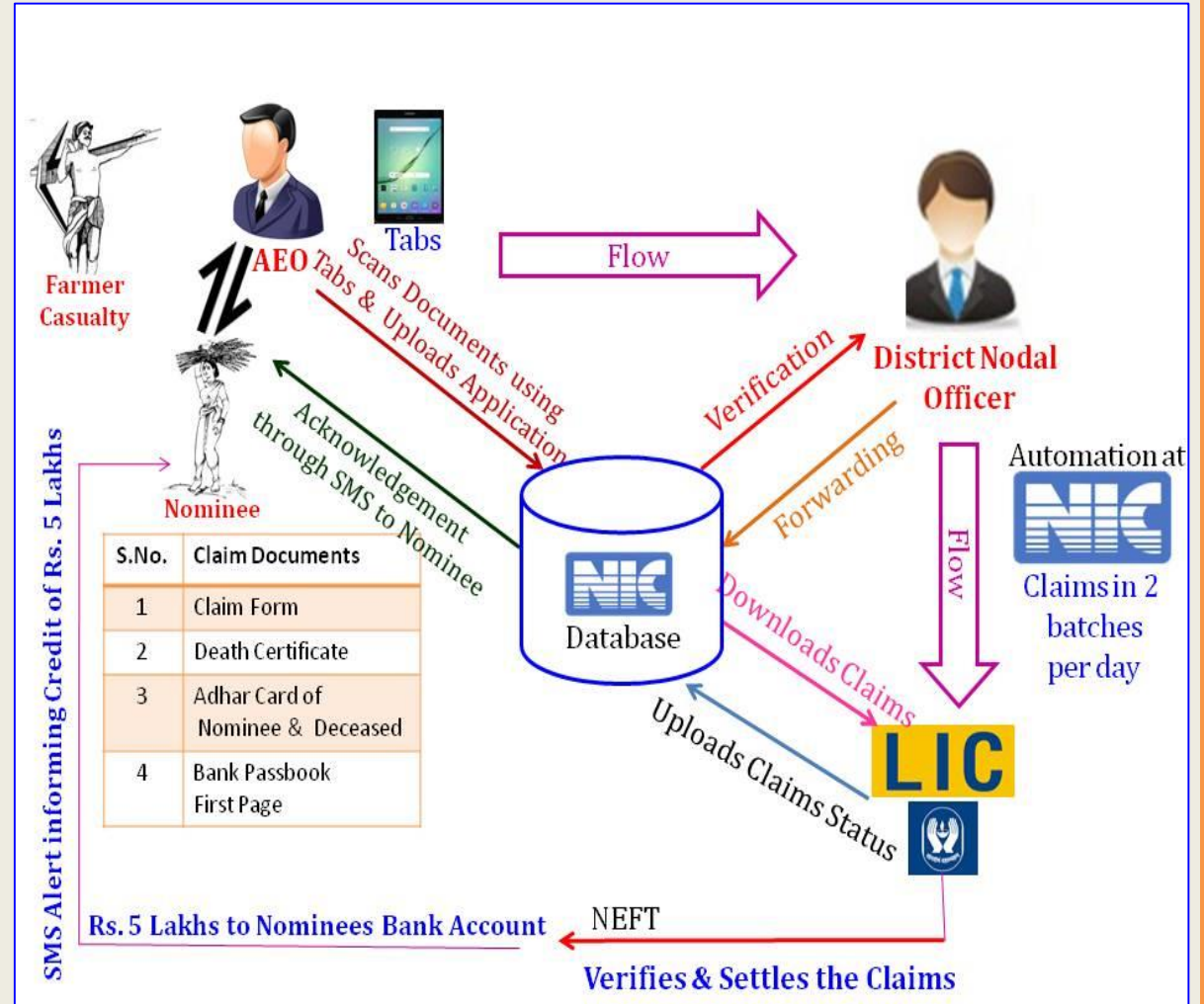

# ***RYTHU VEDIKA***

- Rythu Vedikas are the first of its kind in India with an objective to provide common platform to bring farmers, Agriculture Officials and Scientists closer to discuss and find solutions on farmers issues
- The Government has taken an initiative to construct 2601 Rythu Vedika Work Sheds in every Agriculture Extension Officer Cluster consisting of 1-3 villages with construction cost of Rs. 22,00,000/- for each Rythu Vedika with a share of Rs. 12.00 Lakhs from the Department of Agriculture and Rs. 10.00 Lakhs from MNREGS funds
- Rythu Vedikas are equipped with basic amenities for organising Trainings on package of practices and innovations in Agricultural and allied sectors.

# Palle Pragathi

Government of Telangana has launched the Palle Prathi Program with the twin objective of enhancing the quality of life in the rural areas and improving the governance of Grama Panchayats.

- It is a continuous program to improve the village sanitation, infrastructure, tree cover and governance of the gram Panchayats.
- So far, four campaign rounds of Palle Pragathi have been taken up with the various activities like
  - i. Cleaning of roads & drains.
  - ii. Identification of low lying areas & filling up with gravel.
  - iii. Bailing out of water from low lying areas.
  - iv. Identification of old & dilapidated houses, offices for demolition & cleaning of debris.
  - v. Filling up of old and unused open wells.
- An amount of Rs.8617.45 crores was spent from September 2019 to December 2021, duly meeting equal amounts from Central & State Finance Commission grants.

Various other developmental activities being implemented by the State Government are as follows:

- i. Vykuntadhammam/ Crematorium have been sanctioned in all 12769 Gram Panchayats and construction completed in 12714 Gram Panchayats with an expenditure of Rs.1308.84 Crores.
- ii. Village Dumping Yards have been sanctioned in all 12769 Gram Panchayats and construction completed in 12751 GPs, for which Rs 277.84 Crores was spent.
- iii. Establishment of functional nursery in 12759 Gram Panchayats. In 2020-21, 18.84 Crore for which seedlings have been raised for which Rs.271.23 Crores has been incurred.
- iv. Palle Prakruthi Vanams with dense forest type plantations have been established in 19472 Gram Panchayats and habitation which are serving as village nature parks and rural lung spaces. Expenditure of Rs.222.06 Crores has been incurred for this purpose.

- v. Bruhat Palle Prakruthi Vanams are being established in each mandal. Land identification is completed in 785 sites against a target of 2725. Plantation works are completed in 98 sites and expenditure of Rs.28.33 Crores has been incurred.
- vi. Multi-Layer Avenue Plantation is proposed with a target of 250 KMs in each District. Against target of 8000 KMs, plantation has been completed in 8305 KMS and Rs.26.42 Crores has been incurred.
- vii. 11,64,643 individual and 32,941 community soak pits have been constructed in the State in all GPS, for which an amount of Rs.416.87 Crores has been utilised.
- viii. 2597 Rythu Veditas have been constructed in the State, for which an expenditure of Rs.515.18 Crores.
- ix. 49170 Drying Platforms have been grounded and 19309 are completed, duly incurring expenditure of Rs.124.00 Crores.
- x. Total expenditure under Palle Pragathi programme has been Rs.10853.20 Crores.

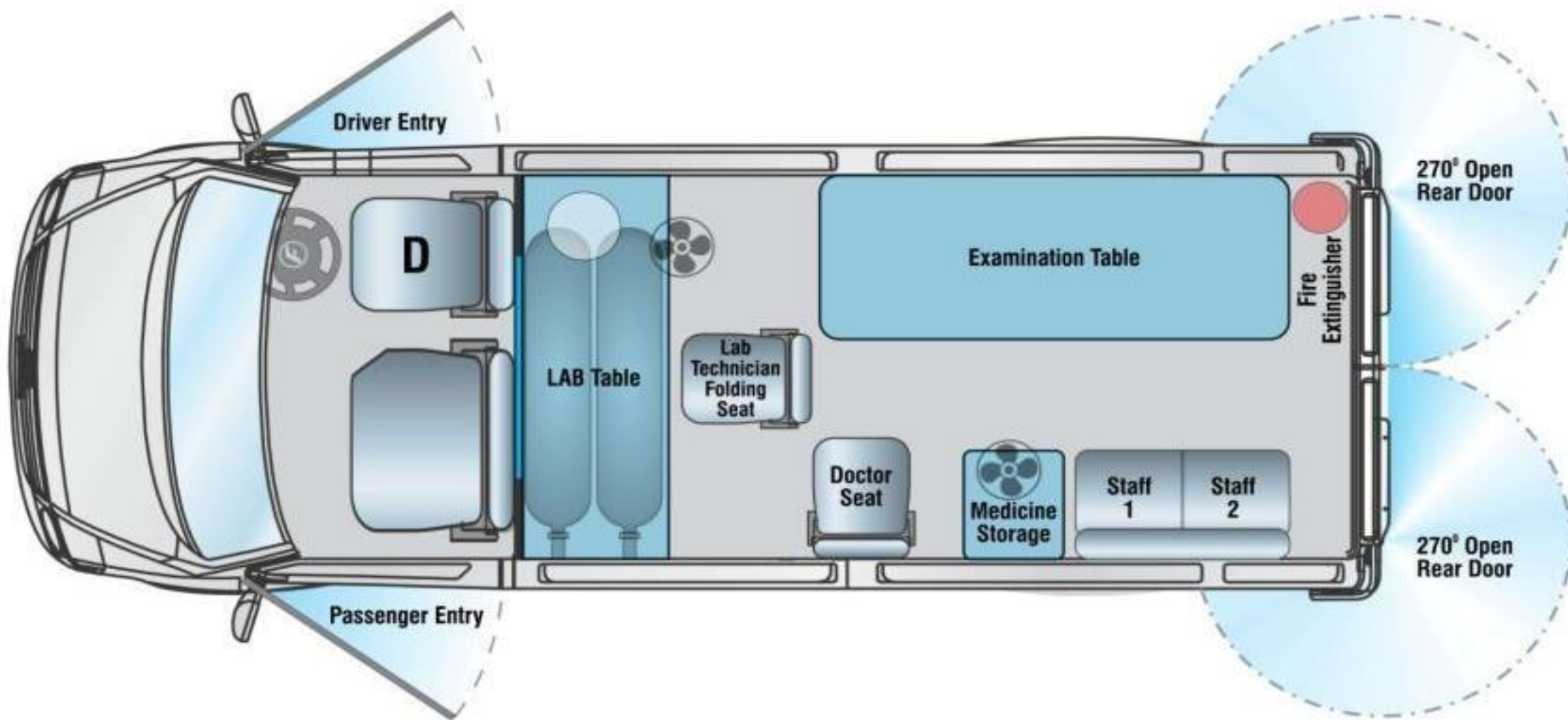

# SHEEP REARING DEVELOPMENT SCHEME

## Objectives of SRDP Scheme:

- To increase the Rural economy in the State especially of Shepherd Community (Golla, kurma/Kuruva and Yadava communities) through Sheep rearing,
- To make the state self sufficient in meat production, export of meat to other countries and
- To strengthen the Primary Sheep Breeder Cooperative Societies in the State with the financial assistance of National Co-Operative Development Corporation (NCDC), New Delhi.

*The project is being implemented in 2 phases to cover a total of 7,31,368 members . The total project outlay for the first phase is Rs.5,000 crores intended to cover 4.0 lakh beneficiaries. First phase of Scheme has been commenced in the year 2017.*

# OUTCOME OF THE PROJECT

- The sheep population has been increased from 1.28 crore to 1.91 crore by the induction of sheep under SRDP scheme and the same has been confirmed by the Govt. of India (20<sup>th</sup> Livestock census).
- So far, 130.20 lakh lambs (estimated) were born and Rs.7,800.00 crore worth of rural wealth has been accrued out of the lambs born.
- Approximately 1.22 lakh MTs of Meat added to the market after induction of Sheep.
- Steep increase (106.29%) in Meat production from 2014-15 to 2020-21
- Increase in per capita availability of meat from 12.95 Kg during 2014-15 to 21.17 Kg during 2020-21 due to increased mutton production.

# SRD SCHEME- PHASE II

- Government intends to distribute Sheep Units to all the balance eligible members of primary Sheep Breeders Co-Operative Societies (PSBCS) in the State during Phase II Scheme. Accordingly, Government vide GO MS No.14, Dt.04/08/2021 have enhanced the Unit cost from Rs.1,25,000/- to Rs.1,75,000/-. II phase scheme will be implemented in two years i.e 2021-22 and 2022-23.
- No. of Beneficiaries to be covered in 2<sup>nd</sup> phase : 3.50 lakh
- Unit cost approved by the Government : Rs.1,75,000/- (Govt. Share Rs.1,31,250/- and Beneficiary Share Rs.43,750/-)
- Total Financial outlay (II phase) : Rs.6,125.00 Crore ( Government Share Rs.4593.75 and Beneficiary Share Rs.1531.25 Crore)

# IMPACT OF THE SCHEME

- A team from NCDC, New Delhi has made field visits in (7) districts and interacted directly with the beneficiaries, to know the impact of the scheme in the State and expressed satisfaction over the implementation of the Scheme
- Income levels and social status of the Shepherd Communities have been enhanced in the State.
- Per capita consumption of the meat has been increased.
- Import of Sheep from other States for slaughter has been reduced drastically ( From 600 lorries per day in 2017 to 100 lorries per day at present).

# Milch Animal Distribution scheme

- The increasing the procurement has taken place due to support of the government by way of providing one milch animal to farmers of Milk Federation(Vijaya Telangana) & Other Milk Unions in the State.
- **Unit cost:** Rs.80,000/- per animals which includes cost of animals, insurance and Feed (300 Kgs).
- **Subsidy:** SC/ST is 75% and for Others is 50%.
- **Beneficiary contribution :** For SC/ST: Rs. 20,000/- for Others : Rs.40,000/-
- Total districts to be covered : 31
- Total members to be covered : 2,13,917
- No. of milch animals to be provided : 2,13,917
- Animals grounded so far : 59012
- Total Project Cost : Rs 1677.11 Crs
- Subsidy : Rs. 917.49 Crs



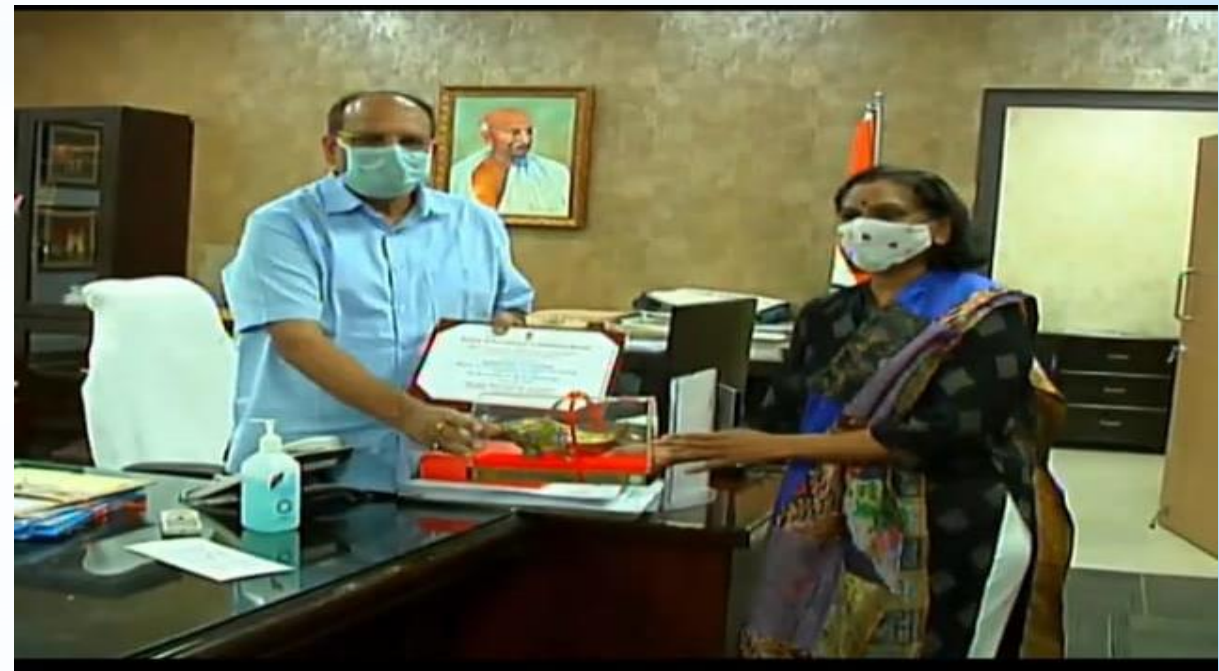

# Kalyana Lakshmi Pathakam and Shaadi Mubarak scheme

- Government of Telangana introduced the scheme of “Kalyana Lakshmi Pathakam” in respect of SCs/STs/Minority unmarried girls to meet their marriage expenses from October’ 2014 and for BCs/EBCs from April, 2016.
- Financial assistance of Rs.51,000/- was given upto Dt:- 31.03.2017, Rs.75,116/-, upto dt:- 31.03.2018, Rs.1,00,116/- from 01.04.2018 till date.
- The girl should have completed 18 years of age at the time of Marriage.
- The combined income of parents shall not exceed Rs.1,50,000/pa in respect of Rural Areas andRs.2,00,000/pa in respect of Urban Areas for BCs/EBCs.
- For SC/ST/Minority girl, the income limit is Rs.2,00,000/per annum.
- Rs.1,25,145/- is the subsidy given to disabled girls under Kalyana Lakshmi Pathakam/Shaadi Mubarak Scheme irrespective of Caste in view of Section 24 (1) of the Right of Persons with disabilities Act, 2016 vide G.O.Ms.No.04, BC Welfare (B) Dept., Dt: 29.06.2019.

# MAHATMA JYOTHIBA PHULE OVERSEAS VIDYA NIDHI FINANCIAL ASSISTANCE

- “Mahatma Jyotiba Phule Overseas Vidya Nidhi” Scheme is introduced to BC and EBC students to pursue Post Graduation/P.hd courses abroad.
- The students are permitted to study in 10 countries with the scholarship amount. They are USA, UK, Canada, Australia, Singapore, Germany, New Zealand, Japan, France & South Korea.
- A Financial assistance (grant) of Rs.20.00 Lakhs along with Air Ticket fare up to Rs.50,000/- and Visa Charges per student are given, provided the annual family income does not exceed Rs.5.00 Lakhs per annum under the scheme.
- A target of 300 students i.e. 285 OBC students +15 EBC students has been fixed annually for 2 sessions, Fall and Spring.

# POST MATRIC SCHOLARSHIPS AND REIMBURSEMENT OF TUITION FEES TO BC AND EBC STUDENTS

- Government of Telangana is implementing Post Matric Scholarship and Reimbursement of tuition fees Schemes on saturation basis from the year 2008-09 onwards to enable the poor and eligible students for further studies from Intermediate to PG courses.
- Students who are admitted under Convener Quota (Category – ‘A’) are eligible.
- Eligibility Criteria: Income limit of parents shall be Rs. 1.5 lakhs in Rural Areas & 2.00 Lakhs in Urban Areas.
- Every year around 7.5 lakh BC students and 1,5 lakh EBC students are registered.
- Around Rs.1500 Crore is allocated in the state’s budget for this scheme.
